**General Meeting Minutes**

#### A. General Announcements

### B. Emergency Management—Brandy Karny

The purpose of the Cuyahoga County Emergency Management team is to foster a state of preparedness throughout the county. Representatives from various groups within the County participate in the Public Safety Urban Area Working Group (PSUAWG). This group was established in 2/2009. Citizens Corp has representation on this group. The biggest efforts of this group are in exercises and training. Emergency Management plans are also established which identify what needs to be done for each type of emergency event. The level of County preparedness is evaluated for training, planning, exercises held, equipment and the establishment of a PSUAWG. Preparedness partners include FEMA, Ohio Emergency Management, Local Fire Departments and CERTs.

Flooding is the #1 threat in Cuyahoga County. Ten disasters have been declared in Cuyahoga county since 3/24/1964. A presidential declaration of a disaster is needed to get financial assistance from the government. The following disasters have been declared:

- Flood, 2006
- Power outage, 2003
- Flood, 2003
- Blizzard, 1978

#### C. Red Cross—Phil Trimolt

A Family Preparedness booklet was distributed. The goal is to prepare now for a future incident. The booklet gave details about the three steps to preparedness. The best way to prepare is to create a preparedness kit, make a plan and be informed.

- 1. Prepare a kit—The main items to consider for a kit are with regard to safety, comfort and survival.
- 2. Make a plan—Take responsibility for yourself and your family. Make copies of important documents. Coordinate an out-of-town contact and know the number to call. Write down the plan and share it with the members of your family. Everyone in the family should have a job to do.
- 3. Be informed—Utilize available web sites to learn what to do in the event of an emergency (i.e. ready.gov). Have an emergency radio available.
